

EASL meetings- Abstract submission information

Types of presentations

All accepted abstracts submitted in this format (abstract /late-breaker abstract) will be either presented as:

- 1) An **oral presentation** or
- 2) An **ePoster presentation** (which upon selection can also be included as an oral ePoster session)

Abstract submission fees

Abstract submission for all EASL meetings (except for ILC) is **free of charge**.

Abstract changes

- All changes can be made by the abstract submitter **until the abstract submission deadline** of the respective meeting
- **After** the abstract submission deadline, **only the presenting author** can be changed until 3 weeks prior the event start date

Abstract withdrawals

- After you submitted your abstract, requests for withdrawal of an abstract must be received in writing to abstracts@easloffice.eu **latest until that abstract submission deadline** of the given EASL meeting
- No refund will be granted after the submission deadline of the given EASL meeting (ILC's only)
- Any withdrawal requested **after** the abstract submission deadline of the given EASL meeting will not be considered and the abstract will be published

Abstract disclosures (COI and off label products)

- **Conflict of interest:** For each author, any relevant financial relationship with the provider of commercial products or services discussed in their educational presentation or that have directly supported the CME activity through an educational grant to the sponsoring organization(s).
- **Off label products:** If the product, that is discussed in the abstract, is not labelled for the

use under discussion or that the product is still investigational.

Note: The intent of disclosure is not to prevent a participant with financial or other relationships from making a presentation, but rather to provide participants with adequate information about the relationship(s).

Embargo policy

By submitting an abstract to ILC, you agree to adhere to the conference embargo policy. The policy specifies that while authors may publish the fact that their abstract has been selected for inclusion in the conference programme, data from the abstract may NOT be shared in any form (print, broadcast or online publication, media release or conference presentation) prior to its official release by EASL.

As is the case with most scientific and medical conferences, ILC abstracts are released to delegates and media under a strict embargo policy. A detailed breakdown of the embargo policies for different types of abstracts is available below. All conference delegates, presenters and media agree to respect this policy.

- Oral abstracts (excluding ILC late-breakers): The oral abstract texts and presentations (excluding all late-breaker abstracts) may not be public two days prior to when pre-recorded presentations are released.
- ILC ePoster abstracts: The ePoster abstracts (including ePoster late-breaker abstracts), including pre-recorded description video may not be public two days prior to when the full ePoster are released for viewing.
- ILC Late-breaker oral abstracts (excluding those in an ILC Official press conference): Late-breaker oral abstracts texts and presentations may not be published or presented before the start of the session in which the abstract is presented.
- Abstracts in an ILC press conference: The embargo on oral abstracts included in an official ILCpress conference lifts at the start time of the press conference in which the abstract is featured. Authors will be informed in advance if their abstract has been selected for an EASL press conference.

Copyrights

By submitting an abstract to an EASL event you agree with the following statement:

"I hereby assign all copyrights to the European Association for the Study of the Liver (EASL), for the abstract submitted to the "relevant EASL meeting name" (government authors not electing to transfer, agree to assign an exclusive publishing and distribution license) and any supplemental tables, illustrations or other information submitted therewith that are intended for publication as part of the abstract in all forms and media (whether now known or hereafter developed), throughout the world, in all languages, for the full term of copyright, effective when, and if, the article is accepted for publication. This transfer includes the right to provide the abstract in electronic and online forms and systems."

Copyrights related to abstract data made available on the website and in the printed material resides with the respective authors.

No reproduction, re-use or transcription for any commercial purpose or use of the content is permitted without the written permission of the authors. Permission for re-use must be obtained directly from the author.

Note: Violation of this policy will be taken seriously. Individuals and/or sponsors who violate it may face sanctions relating to current and future abstract submissions, presentations and visibility at any EASL event. The EASL Governing Board is at liberty to ban attendance and/or retract data.
