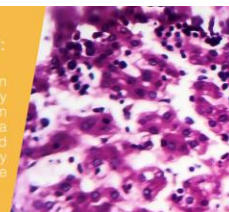

Definitions

Viral Hepatitis Elimination 2022 is organised by the European Association for the Study of the Liver (EASL™).

These General Terms and Conditions shall manage your registration and participation to the Viral Hepatitis Elimination 2022 and the use of our platform.

Congrex Switzerland Ltd is the registration system data processor of the Viral Hepatitis Elimination 2022, 24-25 February on behalf of European Association for the Study of the Liver. The provider supports the congress secretariat and is responsible for registration services and is hereafter referred to as Congrex Switzerland Ltd.

Condition for registration

These General Terms and Conditions are valid for each attendee registered for the Viral Hepatitis Elimination 2022, 24-25 February. Any registered person (physician, healthcare professional, student, media representative, speaker, exhibitor, etc...) is considered as an attendee. These General Terms and Conditions are also binding for all group registrations.

Registration fees deadlines

Early registrations will be accepted until Tuesday, 4 January 2022 – 23.59h CET.

Should your early registration remain unpaid on Tuesday, 4 January 2022 it will be upgraded to the late registration fee.

As of Wednesday, 5 January 2022 until Friday 25 February 2022 - Midnight CET, late registration fees apply for every new registration.

Modification & Cancellation

For cancellations received prior to **Thursday, 27 January 2022**, midnight CET, deposits will be refunded less **35 euros for administrative charge**. After this deadline, no refund policy will be in effect. *

Once a delegate is confirmed, a minor name correction is still possible. However, **once the registration fee is paid, tickets cannot be transferred to another person.**

If a delegate wishes to change the registration from onsite to online or vice versa.

1. Onsite to online: no additional fee

2. Online to onsite change – A handling fee of **50 EUR per registration** will be charged for every registration modification. Changes are possible until **1st February 2022 only**.

After this deadline, no refund policy will be in effect.

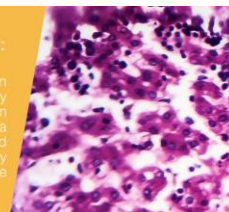

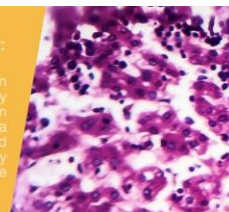

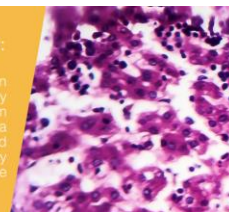

Group Data Management

Names of all participants must be submitted, and reservations assigned online before **1 February 2022**.

Force majeure and cancellation

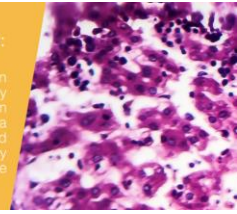

Unacceptable behaviour includes, but is not limited to:

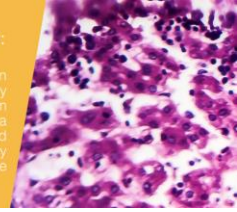
